While Carmichael firmly supports the ACE migration, a successful transition to this new platform requires full system readiness by all participating government agencies and by all industry shareholders along with successful system testing to ensure success from the outset.

We also understand the concern many have with the February 28, 2016 mandatory use deadline. Carmichael has capable software, internal IT support, and a good third party provider; however, the final testing is challenging with the constant changes and updates from Customs. We are determined to being fully live by the deadline and supporting this huge project.

I can tell you that there has been tremendous investment for customs brokers to be ACE compliant. We also cannot yet fully understand the impact on productivity – especially when it comes to PGA's (Partner Government Agencies). We will be evaluating these costs over the coming weeks.
